i. General Assurance

MAT is covered under the Medicaid state plan for all Medicaid beneficiaries who meet the medical necessity criteria for receipt of the service for the period beginning October 1, 2020 and ending September 30, 2025.

ii. Assurances

- a) The state assures coverage of Naltrexone, Buprenorphine, and Methadone and all of the forms of these drugs for MAT that are approved under section 505 of the Federal Food, Drug, and Cosmetic Act (21 U.S.C. 355) and all biological products licensed under section 351 of the Public Health Service Act (42 U.S.C. 262).
- b) The state assures that Methadone for MAT is provided by Opioid Treatment Programs that meet the requirements in 42 C.F.R. Part 8.
- c) The state assures coverage for all formulations of MAT drugs and biologicals for OUD that are approved under section 505 of the Federal Food, Drug, and Cosmetic Act (21 U.S.C. 355) and all biological products licensed under section 351 of the Public Health Service Act (42 U.S.C. 262).

iii. Service Package

From October 1, 2020, through September 30, 2025, the state assures that MAT to treat OUD as defined at section 1905(ee)(1) of the Social Security Act (the Act) is covered exclusively under section 1905(a)(29) of the Act.

The state covers the following counseling services and behavioral health therapies as part of MAT.

Physician – is a physician licensed to practice, and in good standing, in the State of Alaska with a current federal waiver to dispense narcotic drugs for narcotic treatment (as per 21 U.S.C. 823(g)(2)), current registration or exemption to dispense dangerous drugs as per state law, maintains a DATA waiver as required by federal law and who, as applicable, is employed by or contracted with a certified OTP in the state.

Physician's Assistant (PA) - is licensed to practice, and in good standing, in the State of Alaska, maintains a DATA waiver as required by federal law, and operates within the scope of their collaborative practice agreement with a licensed physician, and who, as applicable, is employed by or contracted with a certified OTP in the state.

Advanced Practice Registered Nurse (APRN) – is licensed to practice, and in good standing, in the State of Alaska, maintains a DATA waiver as required by federal law, and has independent prescriptive authority and who, as applicable, is employed by or contracted with a certified OTP in the state. When APRNs do not have independent prescriptive authority, the APRN operates within the scope of their collaborative practice agreement with a licensed physician.

OTP Exempt MAT Provider – a midlevel practitioner, who when granted an exemption from SAMHSA, can operate independently, i.e., without the supervision of a medical director or a program physician, perform the medical director or physician functions in an OTP based on the Federal opioid treatment standards under 42 C.F.R. 8.12.

Registered Nurse (R.N.) – is licensed to practice, and in good standing, in the State of Alaska and operates within their scope of practice and under the supervision of the prescribing provider;

Licensed Practical Nurse (L.P.N.) - is licensed to practice, and in good standing, in the State of Alaska and operates within their scope of practice and under the supervision of the prescribing provider;

Community Behavioral Health Services Provider – a community-based service agency, approved by the department and enrolled in Alaska Medicaid, employing individual rendering behavioral health service providers included in this section. In addition to general conditions for Medicaid participation, including a business license, Medicaid provider agreement, and National Provider Identifier (NPI), CBHS providers must (1) hold a certificate of current grant award issued through the Division of Behavioral Health, (2) hold a certificate of department approval through the Division of Behavioral Health, and (3) ensure their agency and staff, including contractors, sub-contractors, and other vendors meet all other applicable federal and state licensing or certification requirements;

Psychologist – an individual who holds an active license to practice as a psychologist in the State of Alaska, is in good standing, and provides services within scope of practice as defined by state law;

Mental Health Professional - an individual who is working for an enrolled community behavioral health services provider who has a master's degree or more advanced degree in psychology, counseling, child guidance, community mental health, marriage and family therapy, social work, or nursing, is performing community behavioral health services that are within that individual's field of expertise and working under the supervision of a licensed professional in this section; and

Licensed Mental Health Professional - an individual with an active license to practice, and in good standing, as a marital and family therapist, clinical social worker, professional counselor, or psychologist, issued by the State of Alaska.
